

VIP Service Purchase and Usage Agreement

This VIP Service Purchase and Usage Agreement (VSPUA) is a legal agreement between you ('User') and VIP Service Provider ('AIC LLC') governing your use of the VIP Service. By purchasing and/or using the VIP Service, you agree to be bound by the terms and conditions set forth in this Agreement. If you do not agree with these terms, please do not use the VIP Service.

1. Service Description

The VIP Service is an online software/service that provides specific requested services to users within a 24-hour period from submission, subject to the terms outlined in this Agreement.

2. Service Fees

- **Standard Service Fee:** The fee for each VIP Service order is (before taxes):
 - ✧ **IntroMaster:** \$329.40 USD = 600 subscription day;
 - ✧ **MethodReview:** \$164.70 USD = 300 subscription day;
 - ✧ **ResultBoost:** \$164.70 USD = 300 subscription day;
 - ✧ **DiscussionPro:** \$494.10 USD = 900 subscription day;
 - ✧ **VIPPlus:** Depends on the service content. Please provide contact information—Email and phone number)
- **Student Discount:** Verified students are eligible for a discounted fee of (before taxes):
 - ✧ **IntroMaster:** \$32.94 USD = 60 subscription day;
 - ✧ **MethodReview:** \$16.47 USD = 30 subscription day;
 - ✧ **ResultBoost:** \$16.47 USD = 30 subscription day;
 - ✧ **DiscussionPro:** \$49.41 USD = 90 subscription day;
 - ✧ **VIPPlus:** Depends on the service content. Please provide contact information—Email and phone number)

3. Order Frequency

Each user account is permitted to place a maximum of **one (1) VIP Service order per day**. Multiple orders per day from the same account

are not permitted. The Service Provider reserves the right to cancel or refuse additional orders from the same account within a single day.

4. Service Delivery Timeline

The VIP Service will be delivered within **24 hours** of order submission. Service completion times may vary based on demand and other factors, but every effort will be made to meet this timeframe. The Service Provider is not responsible for delays caused by factors outside of its control.

5. Payment Terms

- Users are required to pay the full service fee at the time of order submission.
- Payments are non-refundable once an order has been submitted, except as required by applicable law or at the discretion of the Service Provider in cases where the Service cannot be fulfilled.

6. Account Responsibility

Users are responsible for maintaining the security and confidentiality of their account information. The Service Provider is not liable for any unauthorized access or use of an account due to user negligence.

7. Limitations of Use

- The VIP Service is intended solely for individual use. Unauthorized reproduction, distribution, or resale of the service is prohibited.
- The Service Provider reserves the right to suspend or terminate any account that violates this Agreement or engages in misuse of the Service.

8. Data Confidentiality

- All data uploaded by users during the use of the VIP service, including but not limited to description files and request information, will be kept strictly confidential.
- The service provider commits to using user data only for the purposes necessary to provide the service and will not share, sell, or disclose user data without authorization.

- User data will be securely stored for seven (7) days after the service is completed, after which it will be automatically deleted from the system, unless required by law or the user agrees to extend the storage period.
- The service provider will take reasonable technical and organizational measures to protect the security of user data and prevent data loss, misuse, or unauthorized access.

9. Limitation of Liability

To the fullest extent permitted by law, the Service Provider shall not be liable for any indirect, incidental, special, consequential, or punitive damages, including, without limitation, damages for loss of profits, goodwill, use, data, or other intangible losses resulting from the use or inability to use the Service.

10. Modification of Terms

The Service Provider reserves the right to modify or update this Agreement at any time without prior notice. Continued use of the VIP Service following any such changes constitutes your acceptance of the revised terms.

11. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the jurisdiction in which the Service Provider is located, without regard to its conflict of law provisions.
